## Letter from a Prosthetic Eye Recipient

Dear Ms. Jordan;

I am writing you and all the Lions Lighthouse staff with profound appreciation and gratitude. I received my new completed eye from Angela Cotton on July 7, 2009 and it is a work of art. I find myself constantly looking in the mirror in total disbelief. My eye loss was caused by years of damage due to a rare and chronic case of Stevens Johnson Syndrome. I have travelled around the country seeing various specialists, and in 1979 moved my family to Atlanta to be under the care of the late Dr. Louis Wilson. Emory treated me as a research patient and I toured the country teaching cornea fellows and residents about my condition.

In 1987 I lost the battle with my right eye after three cornea transplants. I continued to hold out for a medical break through but none came. In 2005 I visited the Mayo Clinic in Rochester, Minn. They recommended removing the eye, and this last November the eye was removed.

Dr. Kim from Emory said that the scar tissue was so great they didn't believe prosthetics was possible, but referred me to Angela Cotton anyway. Ms. Cotton said to me "I love a challenge." My next big hurdle was how to pay for this challenge, and you folks made that part happen. And now I have this beautiful new eye that most people close to me cannot tell which eye is the new one. My grandchildren have lost their "good pirate" as I was known with my patch on.

Over the years I have always done a lot of public speaking and involved in community groups. The bad right eye forced me to slow down out of self consciousness. This new eye means more to me than you can ever imagine. For many years I was in the broadcast industry and practiced law for about twenty years. I served as confidant to former mayors Maynard Jackson and Andy Young. These last few years of economic downturn forced us to close our two restaurants here in Atlanta... But with this new appearance I look forward to the re-build... God bless you and Angela Cotton, and I thank you from the bottom of my heart.
